#### 1. Author/Authors

##### 1) A Work by Two Authors:

##### 2) A Work by More than Three Authors: Use only the first author's last name followed by "et al." in the signal phrase or in parentheses.

- ... (Shim et al., 1993)
- Yoo et al.(1997)...

#### 2. Author/Authors name and date presented in ( ): List researches by the alphabetical order.

- In previous researches (Barbin et al., 1994; Holbrook & Hirschman, 1982; Kim, 1998; Kim & Park, 2002)...

#### 3. Groups as authors (government agency) as publisher: List researches by the alphabetical order. The names of some group authors are spelled out in the first citation and abbreviated in parenthetical text ( ) thereafter. If the abbreviation is familiar or readily understandable, you may abbreviate the name in bracket text [ ]

- National Institute of Mental Health (2005)...

- First citation : Korea Research Institute for Fashion Industry ([KRIFI], 2011)...
- Second citation: ... (KRIFI, 2011).

#### 4. Translation: After the name of original author, add the original date of the work's publication and the date of translation in parentheses at the end of the entry.

#### 5. Articles in journals or newspaper without an author: put "" on its short title, add the date of the publication.

- ... market of womens wear ("Study Find", 1982)

- ... in fashion distribution ("Consumer Reports", 2007)

#### 6. Unknown Author (Book, Guidebook, Report etc.): Begin the entry with the work's title. Titles of books are italicized.

#### 7. 2nd Reference: After the name of the original author, present the source of reference in parentheses.

- Seidenberg and McClelland's study (as cited in Clothart et al., 1993)...

#### 8. References to Legal materials: Give the official name of the act in 「 」 When the official name is in Korean, use space between words.

\* Manuscript must be clearly presented in English.

\* Citations made in the article must have listed on the reference. The list should follow the alphabetical order.

\* All lines from the second line of each entry in your reference list should be indented "3칸"(Hangeul) or 1.27 cm (MS Word) from the left margin.

\* Footnote or Endnote cannot replace the reference.
